As already announced in the political introduction to the Draft Budget 2017, EUR 10 million from the Development Cooperation Instrument is to be allocated to the Facility for Refugees in Turkey in 2017, in order to reach the EUR 750 million contribution from the EU budget to the Facility in 2017.

d) Detailed grounds for the transfer

The present proposal to transfer EUR 10 million to the Instrument for Pre-Accession Assistance is necessary in order to mobilise the funding of the Facility for Refugees in Turkey in 2017 in the optimal and most flexible way. The amount transferred will be used within the framework of the Special Measure on Education, Health, Municipal Infrastructure and Socio-Economic Support that was adopted in July 2016 (C(2016) 4999 final) and which is currently being modified to address urgent refugee needs in Turkey in the priority areas of education and health and municipal infrastructure.
