1. The General Secretariat of the Council has been informed of the resignation of Ms Ruta PORNIECE as member of the Governing Board of the above Foundation in the employees' representatives category (for Latvia).
2. Under Article 6 of Regulation (EEC) No 1365/75, as amended by Regulation (EC) No 1111/2005, members and alternate members of the Governing Board are appointed by the Council.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EEC) No 1365/75 of 26 May 1975 on the creation of a European Foundation for the Improvement of Living and Working Conditions¹, and in particular Article 6 thereof,

Whereas:

- (1) In its Decision of 28 November 2016², the Council appointed the members and alternate members of the Governing Board of the European Foundation for the Improvement of Living and Working Conditions for the period ending on 30 November 2019.
- (2) A seat as member of the Governing Board of that Foundation in the employees' representatives category has fallen vacant as a result of the resignation of Ms Ruta PORNIECE.
- (3) The employees' organisation ETUC has submitted a nomination for the vacant seat,
