Directives for the negotiation of an agreement between the European Union and the Global Green Growth Institute on Union membership of the Global Green Growth Institute

- 1. The Commission shall endeavour to ensure that an agreement leading to Union membership of the Global Green Growth Institute ('GGGI') is consistent with relevant Union legislation.
- 2. The Commission shall conduct negotiations in accordance with relevant Union legislation in force or agreed positions of the Union established specifically for the purposes of these negotiations within the special committee of representatives of the Member States referred to in Article 3 of this Council Decision or within the Council.
- 3. The Commission shall report to the Council on the outcome of the negotiations and, where appropriate, on any problem that may arise during the negotiations.
