

In accordance with Article 7, paragraph 2 a and 2 b of the association agreement, the Mission of Switzerland to the European Union herewith notifies the General Secretariat of the Council of the European Union that Switzerland accepts, subject to the fulfilment of its constitutional requirements, the content of the enclosed appendix to the notification of the Council, which forms an integral part of this reply, and will implement it in its internal legal order.

In accordance with Article 7, paragraph 2 b of the association agreement, Switzerland shall inform the General Secretariat of the Council of the European Union without delay about the fulfilment of its constitutional requirements.

General Secretariat of the Council of the European Union Directorate general D Justice and Home Affairs Brussels In accordance with Article 7, paragraph 3 of the association agreement, the notification of the Council dated 31 May 2017 and this reply give rise to rights and obligations between Switzerland and the European Union and thus constitute an agreement between Switzerland and the European Union.

This agreement shall enter into force on the date of notification by Switzerland about the fulfilment of its constitutional requirements. It may be denounced in accordance with the provisions of Articles 7 and 17 of the association agreement.

A copy of the present note is addressed to the European Commission, General Secretariat, SG.A.3, Brussels.

The Mission of Switzerland to the European Union avails itself of this opportunity to renew to the General Secretariat of the Council of the European Union the assurances of its highest consideration.
