a) **Information from the Presidency on current legislative proposals**

The Presidency informed delegations that it would brief Ministers at the Mixed Committee at Ministerial level on 3 March 2014 on a number of current legislative proposals, including the draft Decision simplified regime for the control of persons at the external borders, two draft Regulations amending Regulation 539/2001 ("Moldova" and "19 third countries"), the draft Regulation on surveillance of the external sea borders in the context of operational cooperation coordinated by the European Agency for the Management of Operational Cooperation at the External Borders of the Member States of the European Union and the Smart Borders Package (EES and RTP).

b) **Implementation of the financial programmes 2014–2020 for Home Affairs**

The Mixed Committee at Ministerial level will be informed by the Commission on the state of implementation of the funds from the MFF Home Affairs.
