Subject	Budget for SISNET for the year 2014

---

1. The Financial Regulation as established by Council Decision 2000/265/EC of 27 March 2000 on the establishment of a financial regulation governing the budgetary aspects of the management by the Deputy Secretary-General of the Council, of contracts concluded in his name, on behalf of certain Member States, relating to the installation and the functioning of the communication infrastructure for the Schengen environment, 'SISNET'<sup>1</sup>, as subsequently amended, provides in its Article 8 that the Member States referred to in Article 25 of that Financial Regulation, meeting within the Council, shall adopt the budget, once the Working Party for Schengen Matters (SIS/SIRENE) has delivered its opinion on the preliminary draft budget.
2. In its meeting of 31 October 2013, the Working Party for Schengen Matters (SIS/SIRENE) has delivered a favourable opinion on the preliminary draft budget, as set out in document 15175/13 SIRIS 86 VISA 212 COMIX 568.

3. It has also agreed that by way of derogation to Article 28(1) of the referred Financial Regulation, the entirety of the contributions of the concerned Member States and Iceland, Norway, Switzerland and Liechtenstein, shall be paid in a single invoice by 1 April 2014, instead of two invoices.
4. The contributions from the concerned Member States and Iceland, Norway, Switzerland and Liechtenstein shall be calculated according to the distribution key laid down in Article 26 of the abovementioned Financial Regulation.
5. On this basis, COREPER is invited to submit the budget for SISNET, as set out in annex, for adoption to the Member States referred to in Article 25 of the abovementioned Financial Regulation.
6. The Secretary-General shall notify the decision to adopt the budget to the States referred to in Article 25 of the above-mentioned Financial Regulation.
