The Presidency announced that an agreement had been reached with the European Parliament on the proposal for a European Maritime and Fisheries Fund as set out in 6152/14 ADD 1 REV 1 (consolidated text).

The Commission representative welcomed the agreement which it considered very satisfactory. He underlined that the Commission would only formally reach a position on the agreement the following Friday. The Commission intends at the formal adoption to issue two statements, one in relation to the addition of Article 349 TFEU as legal basis which it accepts in a spirit of compromise, and one in relation to the Latvian concerns regarding SMEs.

The Netherlands delegation expressed its dissatisfaction over the fact that Article 129a on pulse trawl, which was part of the Council's General Approach, was not part of the agreement. It considered that this was a deviation from the Presidency's negotiating mandate and the omission had taken place in a non transparent manner. The omission is a serious issue which needs a solution in the short term and should be brought before the Council.

The Danish delegation wanted to see clarified whether money for storage aid could be used for the development of sustainable fisheries and aquaculture instead. The Romanian delegation regretted that the funds available for aquaculture had been reduced and maintained its reserve for the time being. The Latvian delegation welcomed the Commission statement regarding SMEs. It was not totally satisfied with various elements of the agreement reached and might abstain at the formal adoption.

The German delegation supported the agreement and recalled that it would make a statement regarding its constitutional system at the time of the formal adoption. The Polish delegation could accept the agreement. Likewise, the Croatian delegation accepted the agreement but considered issues such as the reduction of power of engines and the required days at sea to be bitter pills.

The Presidency stated that the issue of pulse trawl should be part of the discussions on the Omnibus proposal and welcomed the statements by the Commission. He noted that a qualified majority was in favour of the agreement and that the European Parliament would be now officially informed of the Council's endorsement of the agreement.

Delegations largely welcomed and gave their support to the orientation note while offering comments on particular issues. The Committee agreed on having a very focused agenda and a short joint statement.

The Committee decided to task the COTRA, PSC and TPC working parties to contribute to the preparations and to report back to this Committee in due time.

The Committee also decided to revert to the Summit's preparations at a later date following further preparation in the relevant preparatory bodies of the Council as regards the Summit agenda, the Joint statement and the deliverables.

The Hungarian delegation requested to insert the following declaration into the minutes:

"Hungary shares the view that the functioning of the European Union Solidarity Fund should be improved and therefore certain amendments to the Regulation of the European Parliament and of the Council amending Council Regulation (EC) No 2012/2002 establishing the European Union Solidarity Fund constitute important developments. Nevertheless, Hungary wishes to express its conviction that there is a crucial need for the comprehensive review of the European Union Solidarity Fund. Hungary firmly believes that it is necessary for the Union to have at its disposal a sound and flexible instrument to allow it to show solidarity and send a clear political signal as well as imminent and genuine assistance to citizens affected by major emergency situations irrespective of the nature of the disaster be it a natural catastrophe or an industrial accident or crime."

Hungary wishes to point out the serious loophole in the European legislation as the existing EU legislation fails to properly address the financial implications of such events. The potential scale, the long-term environmental, human and economic effects, as well as the trans boundary nature of industrial accidents and man-made disasters call for a review of the existing legislative framework. Hungary emphasizes that in the course of the review process the broadening of the scope of the European Union Solidarity Fund to industrial disaster and crime should be considered. Another option concerns environmental liability and proposes to establish a European Industrial Disaster Risk-sharing Facility as already raised at the meeting of the Environment Council on 19 December 2011 (doc. 18596/11 ENV 972 IND 179 PROCIV 170). Without prejudice to the 'polluter pays principle' as established by the Treaty on the Functioning of the European Union, Hungary considers that the co-legislators should engage themselves to find the proper solutions to these significant controversies without further delay. Hungary regrets that the present Proposal failed to address these important challenges."
