**ACCORDING TO FRAMEWORK DECISION 2003/577/JHA**

We hereby inform you that legal acts implementing Council Framework Decision 2003/577/JHA of 22 July 2003 on the execution in the European Union of orders freezing property or evidence (hereinafter – Framework Decision) in the Republic of Lithuania entered into force on 15 June 2017; these legal acts amend the previous provisions implementing the Framework Decision.

In accordance with Article 9(3) of the Framework Decision we hereby inform you that as from now the Republic of Lithuania will accept certificates drafted in or translated **into the Lithuanian language**.

Furthermore, we hereby inform you that the following are designated as the receiving institutions:

- **the regional prosecutor's office** where the property or evidence is located;
- **the General Prosecutor's Office of the Republic of Lithuania:**
  - (a) when the precise location of the property or evidence cannot be established;

or

(b) when the property or evidence is located in different regions and the execution of the orders freezing the property or evidence involves actions in the territories covered by several regional prosecutor's offices and it is therefore necessary to coordinate the execution of the order freezing the property or evidence.
