**Notification by the Slovak Republic  
regarding Council Framework Decision 2006/783/JHA of 6 October 2006 on the application of  
the principle of mutual recognition to confiscation orders**

The Slovak Republic hereby issues the following notification:

Council Framework Decision 2006/783/JHA of 6 October 2006 on the application of the principle of mutual recognition to confiscation orders has been transposed into Slovak law by Act No 316/2016 Coll. of 25 October on the recognition and enforcement of a property-related decision in criminal proceedings in the European Union and on amendments to certain acts. The above Act entered into force on 1 January 2017.

**Declarations by the Slovak Republic**  
**regarding Council Framework Directive 2006/783/JHA of 6 October 2006 on the application**  
**of the principle of mutual recognition to confiscation orders**

**Re Article 3(1)**

Where the Slovak Republic is the issuing State, the authority competent to forward the certificate and the property-related decision shall be the local court which took the decision at first instance.

Where the Slovak Republic is the executing State, the authority competent to accept the certificate and the property-related decision shall be:

*Ministerstvo spravodlivosti Slovenskej republiky*  
*Župné námestie 13*  
*813 11 Bratislava*

**Re Article 7(5)**

The Slovak Republic declares that the competent authorities will neither recognise or execute confiscation orders in circumstances where such orders were issued under the extended powers of confiscation referred to in Article 2(d)(iv).

**Re Article 19(2)**

The Slovak Republic declares that the certificate must be accompanied by a translation into Slovak. In respect of the Czech Republic, the Slovak Republic will accept certificates in Czech.
