Your Excellency,

On 28 July 2017 the European Monitoring Centre for Drugs and Drug Addiction (EMCDDA) and Europol presented to the Council, the Commission and the European Medicines Agency a Joint Report on the new psychoactive substance carfentanil. This Joint Report, drawn up in accordance with Article 5(1) of Council Decision 2005/387/JHA on the information exchange, risk assessment and control of new psychoactive substances, provides an overview of the available information on detections, patterns of use and incidents reported on this substance.

According to the Joint Report, carfentanil has been available in the European Union since at least December 2012 and has been detected in 8 Member States, 47 deaths associated with carfentanil have been reported by 6 Member States; most of the deaths have occurred in the last six months.

Carfentanil belongs to a group of synthetic opioids known as the fentanils. Carfentanil is closely related to fentanyl, which is controlled under the 1961 United Nations Single Convention on Narcotic Drugs.

Carfentanil will be reviewed at the 39th meeting of the WHO Expert Committee on Drug Dependence in November 2017. However, as the substance is not in an advanced stage of assessment in the United Nations system there is nothing which would preclude that a risk assessment is carried out in line with Article 7(1) of Council Decision 2005/387/JHA.

Given the health and social risks posed by the manufacture, trafficking and use of carfentanil, as well as the possible involvement of organised crime and possible consequences of control measures, I consider that this substance should be assessed through a risk assessment, as foreseen by Article 6 of Council Decision 2005/387/JHA.
