Whereas the European Commission should be authorised to open negotiations on and negotiate, on behalf of the Member States, the provisions that fall within the competences of the Member States of a Comprehensive Agreement between the European Union and its Member States, of the one part, and the Kyrgyz Republic, of the other part, to replace the Partnership and Cooperation Agreement establishing a partnership between the European Communities and their Member States, of the one part, and the Kyrgyz Republic, of the other part¹,

HAVE ADOPTED THIS DECISION:

Article 1

The Representatives of the Governments of the Member States hereby authorise the Commission to open negotiations on and negotiate, on behalf of the Member States, the provisions that fall within the competences of the Member States of a Comprehensive Agreement between the Union and its Member States, of the one part, and the Kyrgyz Republic, of the other part.

Article 2

Article 1 is without prejudice to future decisions of the Member States relating to the designation of their representatives on matters falling within their competences.

Article 3

The negotiations shall be conducted on the basis, where applicable, of the negotiating directives of the Council set out in the addendum to Council Decision (EU) 2017/...¹⁺.
