I'd imagine this means (for example), to take away the right to employment, to take away the right to benefits, to take away the right to better one self or seek a better life, to take away security and liberty, to take away right to legal remedy and/or access to justice, to take away the right to health care, etc.

Thank you for your request for access to documents of the Council of the European Union.<sup>1</sup>

We would like to recall that "[a]pplications for access to a document shall be made [...] in a sufficiently precise manner to enable the institution to identify the document." <sup>2</sup>

The General Secretariat of the Council has examined your request on the basis of the applicable rules: Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents (OJ L 145, 31.5.2001, p. 43) and the specific provisions concerning public access to Council documents set out in Annex II to the Council's Rules of Procedure (Council Decision No 2009/937/EU, OJ L 325,

Article 6(1) of Regulation (EC) No 1049/2001.

Your request covers all documents identifying Council policy on "disenfranchisement", a term you go on to define in a very broad way.

Your request therefore is not precise enough to be processed on the basis of Regulation (EC) No 1049/2001. Trying to do so would furthermore require the General Secretariat to make the very subjective assessment of what may constitute "disenfranchisement" in terms of Council policies. A subjective assessment of this kind is neither a role of the General Secretariat nor can it be the subject of a legally defined individual administrative procedure such as the present one.

We may thus invite you to consult our Public Register (<a href="http://register.consilium.europa.eu/">http://register.consilium.europa.eu/</a>) in order to search for relevant documents yourself.

To be of assistance, we have also run a full text search<sup>3</sup> with the word "disenfranchisement" in registered Council documents, the result of which you will find attached. Any documents with an "N" in the second column can be downloaded via the Public Register.<sup>4</sup> You are welcome to submit requests for access to those of the other documents that may be of interest to you.<sup>5</sup>

Dear Applicant,

In reply to your above-mentioned message, we would like to recall that your request of 09.05.2017 (registered under number 17/1133) has been settled by our letter of 12.05.2017, in which we explained that your request was drafted in too broad a way to be handled under the Access to Documents (ATD) Regulation.<sup>7</sup> Likewise, your request of 15.06.2017 (registered under number 17/1509) was for two specific documents which you received on 22.06.2017.

You now state that you "clarify" your request in the sense that "disenfranchised" means ""deprived of the rights of citizenship especially the right to vote" and that the "adjective 'disenfranchised' describes a person or group of people who are stripped of their power. Rights are violated and they have little power to change life for the better".

This does not add anything to your request 17/1133 that would allow us to consider that there now is a request that can indeed be processed under the ATD Regulation.

Please understand that there is no specific Council policy that would be covered by your request. On the other hand, issues like the ones you refer to can of course pop up in a lot of policy areas and therefore could find themselves incidentally addressed in a potentially large number of documents. There is, however, no practical and objective way to search for and identify such documents. And this is what makes your request impossible to process under the ATD Regulation.

My team will of course be happy to assist you further if you have specific queries (like e.g. do another full text search in undisclosed documents with concrete search terms you may indicate).

But unfortunately, we cannot help you any further with your request as currently formulated.

Subject: FOI query to the EU about the disenfranchised.

Further to receipt your message of July 28, 2017.

Please pass this on to the person who reviews confirmatory applications.

I am filing the following confirmatory application with regards to my access to documents request 'identify Policy Documents about Disenfranchisement'.

From what I read (message of July 28) you suggest there exists no such document. Also, you do not redirect my FOI query. It's interesting to note here the UK's position is essentially the same albeit the UK is a little more reluctant to admit so. I mean no criticism here.

With respect, I'm not satisfied with your response, in part because it is a little patronising but mainly because it is difficult to believe the EU fails to recognise such things. Again, no criticism is intended. So, according to the rules which govern these things, I respectfully request my FOI request is reviewed, without prejudice, by a senior competent officer. Below, I reproduce my original request together with the online dictionary definition of the word 'disenfranchised':
