1. On 11 August 2017, the <u>Commission</u> submitted to the Council two above-mentioned proposals. The proposals concern the Agreement for scientific and technological cooperation between the European Union and the Arab Republic of Egypt setting out the terms and conditions for participation of the Arab Republic of Egypt in the Partnership for Research and Innovation in the Mediterranean Area (PRIMA).

- 2. The text of the Agreement was initialled on 27 July 2017, following the Council's authorisation to the Commission on 30 May 2017 to negotiate on behalf of the European Union an international agreement between the Union and the Arab Republic of Egypt laying down the terms and conditions for participation of the Arab Republic of Egypt in PRIMA.
- 3. Following its meeting on 4 September 2017, the <u>Research Working Party</u> has reached agreement on the texts of the Proposals. UK entered a parliamentary scrutiny reservation.
- 4. It is suggested, therefore, that the <u>Permanent Representatives Committee</u> recommend that the <u>Council</u>, at a forthcoming session:
 - a) adopt, as an "A" item, the Decision approving the <u>signing</u> of this Agreement and its provisional application. The texts of the Decision and the Agreement, following finalisation by the legal linguists, are set out in documents 11915/17 and 11926/17, respectively.
 - b) decide to forward the draft Decision on the conclusion as set out in doc. 11965/17 (as finalised by the legal linguists) as well as the text of the above-mentioned Agreement (as set out in doc. 11926/17) to the European Parliament for its consent.
