- (1) Decision (EU) 2017/1324 of the European Parliament and of the Council¹ provides for the participation of the Union in the Partnership for Research and Innovation in the Mediterranean Area ('PRIMA') jointly undertaken by several Member States.
- (2) The Republic of Lebanon ('Lebanon') expressed its wish to join PRIMA as a Participating State and on an equal footing with the Member States and third countries associated to Horizon 2020 the Framework Programme for Research and Innovation (2014-2020) participating in PRIMA.
