Thank you for your requests for access to documents of the Council of the European Union.¹

I regret to inform you that access to documents 5564/16, 5312/16, 14951/15, 8044/17 and 9221/17 cannot be given for the reasons set out below.

The General Secretariat of the Council has examined your request on the basis of the applicable rules: Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents (OJ L 145, 31.5.2001, p. 43) and the specific provisions concerning public access to Council documents set out in Annex II to the Council's Rules of Procedure (Council Decision No 2009/937/EU, OJ L 325, 11.12.2009, p. 35).

Whereas documents **5312/16**, **5564/16** and **14951/15** are related to the "Proposal for a Regulation of the European Parliament and of the Council establishing a crisis relocation mechanism and amending Regulation (EU) No 604/2013 of the European Parliament and of the Council of 26 June 2013 establishing the criteria and mechanisms for determining the Member State responsible for examining an application for international protection lodged in one of the Member States by a third country national or a stateless person", document **8044/17** concerns cross-cutting definitions on the Qualification Regulation, the Asylum Procedure Regulation, the Dublin Regulation and the Reception Conditions Directive and document **9221/17** deals with "Limiting abuse and secondary movements" Dublin Regulation. They all belong to the so called "asylum legislative package" which is still under discussion.

The documents set out results of the discussions on the abovementioned proposal at Council's preparatory bodies and include Member States' positions and drafting suggestions.

The discussions on these suggestions are still on-going and have not yet been concluded.

Release to the public of the information contained in these documents would affect the internal negotiating process and diminish the chances of the Council reaching an agreement. It could as well affect the Council's position when it comes to negotiating with the European Parliament.

The General Secretariat has weighed your interest in being informed of progress in this area against the general interest that progress be made in an area that is still the subject of negotiations. It considers that, at this early stage, disclosure of the documents which contain opinions for internal use as part of deliberations and consultations within the Council would be premature in that it would impede the proper conduct of the negotiations and compromise the conclusion of an agreement on this subject.

Disclosure of the documents at this stage would therefore seriously undermine the decision making-process of the Council. As a consequence, the General Secretariat has to refuse access to the documents at this stage.²

We have also looked into the possibility of releasing parts of the documents³. However, as the exception to the right of access applies to their entire content, the General Secretariat is unable to give partial access at this stage.

However I would like to inform that, once the acts are adopted, all relevant documents will be made available to the public. ⁴
You can ask the Council to review this decision within 15 working days of receiving this reply (confirmatory application). ⁵

Dear Mr. Chismol Ibáñez,

Thank you for your swift and kind response regarding my request for access to the documents of the Council of the European Union (Ref. 17/1726-ws/). The documents requested include 5564/16, 5312/16, 14951/15, 8044/17 and 9221/17. I would like to submit a confirmatory application regarding the denied request.

The requested documents belong to and cover aspects of the "asylum legislative package" which is currently under discussion. The reason given for the denied request is that access would affect the negotiating process and 'diminish the chances of the Council reaching an agreement.' And that the disclosure of the documents would 'therefore seriously undermine the decision making process of the Council.'

Negotiations surrounding the reform of the Common European Asylum System is understandably sensitive, with diverging preferences among member states making agreement a difficult task in the Council. However, I would like to make an appeal against the claim that having access to these documents will significantly diminish or undermine the decision making process.

I am a PhD candidate from the University of Melbourne and the EU Centre on Shared Complex Challenges, Australia. My research focuses on the challenges and opportunities the EU has faced in developing a common and fair Dublin system. Access to these documents will greatly enhance the originality and depth of my research. Importantly, the use of these documents will remain within the scope of my doctoral research. No material will be published in mainstream news media nor will the documents be shared with other persons. The project has been approved by the University of Melbourne Human Research Ethics Committee, and as part of this approval unprocessed material cannot be shared with persons other than those part of the research project. Any scholarly publications resulting from my doctoral research is not foreseen until October 2018. Consequently, the likelihood that access to these documents will seriously undermine the decision making process in the Council is negligible.
