Statement by Denmark

"Denmark voted against the Commission's proposal on scientific criteria for the determination of endocrine disrupting properties in the Standing Committee on Plants, Animals, Food and Feed on 4 July 2017.

As stated in the joint voting declaration by Sweden and Denmark of 4 July 2017, we expressed regret that the Commission has not listened to the major concern, voiced by Denmark and Sweden and others, that the criteria proposed require an unprecedented high level of evidence to identify endocrine disruptors compared to other problematic substances, such as CMR-substances and do not properly reflect today's scientific knowledge on endocrine disruptors. Denmark further declared that the criteria fail to meet the level of protection foreseen by the co-legislators.

The Legal Service of the European Parliament is currently preparing an opinion on the draft regulation. Further, the European Parliament is scheduled to decide on whether to oppose the Commission's proposal on 2 October 2017. We look forward to seeing the result of the European Parliament's deliberations.

Denmark will closely follow the implementation of the criteria over the coming years, hoping to ensure that the application and further development of the criteria through guidance, does not lead to a lower level of protection. Denmark looks forward to cooperating with the Commission on this matter."
