Thank you for your request for access to documents of the Council of the European Union.<sup>1</sup>

You requested access to "all documents regarding the considerations of the Dutch patent box (innovatiebox)".

The only document held by the Council and corresponding to your request is working paper **WK 3693/2017 INIT**, a meeting document of 28 March 2017 submitted by the European Commission to the Code of Conduct Group (Business Taxation) on the subject of *Standstill: Patent Boxes – NL: Innovation Box amendment*.

The Commission has been duly consulted on the possible release of this document. <sup>2</sup> Based on the information received, the General Secretariat of the Council has come to the conclusion that access currently cannot be given to this document for the reasons set out below.

The General Secretariat of the Council has examined your request on the basis of the applicable rules: Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents (OJ L 145, 31.5.2001, p. 43) and the specific provisions concerning public access to Council documents set out in Annex II to the Council's Rules of Procedure (Council Decision No 2009/937/EU, OJ L 325, 11.12.2009, p. 35).

Article 4(4) of Regulation (EC) No 1049/2001.

The examination of the Dutch fiscal provisions concerned is indeed completed as such. Similar provisions in two other Member States are however still being examined. Considerations contained in the requested document are likely to have an impact on these discussions and the application of relevant provisions as well.

Disclosure of the document would therefore seriously undermine the protection of the public interest as regards the financial, monetary or economic policy of the EU and of Member States concerned. as well as the ongoing decision-making processes. As a consequence, the General Secretariat has to refuse access to this document.<sup>3</sup>

We have also looked into the possibility of releasing parts of the document.<sup>4</sup> However, as the exceptions to the right of access apply to its entire content, the General Secretariat is also unable to give partial access at this stage.

You can ask the Council to review this decision within 15 working days of receiving this reply (confirmatory application).<sup>5</sup>

Regarding: confirmatory application on the subject of the request for the working

paper concerning the Dutch patent box (WK 3693/2017 INIT)

Dear Sir/Madam,

In this letter I want to make a confirmatory application against the statement of 30 August 2017 I cannot agree with the statement and I would like to ask the Counsel to review its decision.

As mentioned m the abovementioned statement, the examination of the Dutch patentbox is completed, but because similar provisions in two other Member States are still being examined, the requested document, (WK 3693/2017 INIT,) will not be released on the basis of Article 4(4) of Regulation (EC) 1049/2001. I understand that the Counsel has consult the European Commission to assessing whether an exception is applicable. In addition, the counsel recommends that the disclosure of the document as previously mentioned seriously undermines the protection of the public interest<sup>1</sup>. This reasoning of the Counsel, I cannot follow.

The provisions of the other Member States regarding patentboxes should be judged in the same way as the Dutch patentbox. In my opinion, releasing revealing the way m which a patentbox is being evaluated would not undermine the public interest because it should not change the way a patentbox is being evaluated. It could only strengthen the public interest by being clear. Releasing the way a patentbox is being judged could contribute to the legal development. In this way patentbox provisions in all Member States could be more uniform, which is an important endeavour of the European Union.

Article 4(1)(a), fourth indent, of Regulat10n (EC) No 1049/2001

The aim of Regulation (EC) No 1049/2001, after all, is to achieve an ever closer union among the peoples of Europe, in which decisions are taken as openly as possible and as closely as possible to the citizens<sup>2</sup>. Openness enables citizens to participate more closely in the decision-making process and guarantees that the administration enjoys greater legitimacy and is more effective and more accountable to the citizens in a democratic system<sup>3</sup>. For this reason I would like to ask the Counsel to reconsider their statement and disclosures the abovementioned working sheet.
