It had an exchange of views on the key outstanding issues to identify areas where the Presidency might be able to show some flexibility with a view to securing agreement on an overall compromise package.

The Presidency will report to the Committee on 16 October to inform it of the outcome of the fourth trilogue and, hopefully, to obtain its approval of an overall compromise package.

The SCA took note of the comments of the FR delegation on the European Court of Auditors' Special Report No 7/2017 on certification bodies. The Presidency urged delegations to coordinate positions with their AGRIFIN colleagues on the draft Council conclusions on this report, which AGRIFIN intends to adopt at its meeting on 13 October.

## **7. Organisation of future work**

The Presidency informed the SCA about the next SCA meeting on 16 October.

The DE delegation informed the SCA about its intention to request at Coreper, for the next "Agriculture and Fisheries" Council meeting on 9 October 2017, an AOB item on the approaches for sustainable and deforestation-free supply chains – cross-learning from palm oil, cocoa and soy.
