d) Detailed grounds for the transfer

Following the Commission proposal (COM(2017)484 final) and the expected Council agreement by 15 October 2017 on the signature and provisional application of the Protocol setting out the fishing opportunities and the financial contribution provided for by the Fisheries Partnership Agreement between the European Union and the Republic of Mauritius, there is the need for EUR 575 000 in commitment appropriations and EUR 220 000 in payment appropriations in 2017.

In addition, EUR 2 500 000 in commitment appropriations and in payment appropriations are needed (the 2nd tranche for 2017/2018) for the amended Protocol to the Fisheries Partnership Agreement concluded between the European Union and the Islamic Republic of Mauritania for additional fishing opportunities (Council Regulation (EU) 2017/719 of 7 April 2017) following the adoption of the related Financing Decision by the Commission's decision (C(2017) 3203 final).

Moreover, concerning additional catches, EUR 129 805 in commitment appropriations and in payment appropriations are needed in 2017 following the implementation of the Protocol to the Fisheries Partnership Agreement with the Republic of Kiribati (Council Decision 2014/60/EU), as well as EUR 393 050 in commitment appropriations and in payment appropriations are required for 2017 following the implementation of the Protocol to the Fisheries Partnership Agreement with the Republic of Seychelles (Council Decision No 2014/306/EU).

Taking into account the needs for Protocols in force (EUR 500 000 in commitment appropriations for the Republic of Cape Verde) until the end of the year, as well as the appropriations still available on the operational line 11 03 01 (EUR 1 660 255 in commitment appropriations), a transfer from the reserve line 40 02 41 of EUR 2 437 600 in commitment appropriations and EUR 3 242 855 in payment appropriations is proposed.
