Recommendation for a

**COUNCIL DECISION**

**approving the conclusion by the Commission, on behalf of the European Atomic Energy Community, of the Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and the Republic of Moldova, of the other part**

## EXPLANATORY MEMORANDUM

### **1. CONTEXT OF THE PROPOSAL**

This proposal is prepared in view of the envisaged signing, provisional application and conclusion of the EU-Republic of Moldova Association Agreement, in order to approve the conclusion of the Association Agreement by the Commission on behalf of the European Atomic Energy Community (EAEC).

Since the EAEC is also a Party to the Association Agreement between the European Union and its Member States, of the one part, and the Republic of Moldova, of the other part, the Commission makes a separate recommendation for Council approval of the conclusion by the Commission of the parts of the Agreement which fall under the Treaty establishing the European Atomic Energy Community (EAEC).

Different procedures apply to the signature and conclusion of international agreements by the EAEC. In particular, in accordance with Article 101 EAEC Treaty, such agreements have to be concluded by the Commission with the approval of the Council. It is therefore necessary to adopt separate Decisions for both the signature and conclusion of the Association Agreement by the EU and by the EAEC.

For the conclusion of the Association Agreement on behalf of the EAEC, the Commission recommends that the Council give its approval, pursuant to the second paragraph of Article 101 of the Treaty establishing the EAEC.

In the light of the results of the negotiations mentioned in the Proposal for a Council Decision on the signing, on behalf of the EU, and provisional application of the Association Agreement between the EU and the Republic of Moldova, as well as the the Proposal for a Council Decision on the conclusion of the Association Agreement between the EU and the Republic of Moldova, the Commission proposes that the Council decides that the Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and the Republic of Moldova, of the other part, should be signed on behalf of the Union and establishes appointment of the person(s) duly empowered to sign on behalf of the Union.

Given the approval of the Council and the appropriate Commission decision, the Commission will be able to sign and conclude the Association Agreement on behalf of the EAEC.

### **2. RESULTS AND LEGAL ELEMENTS OF THE PROPOSAL**

The Commission recommends that the Council approve, pursuant to the second paragraph of Article 101 of the Treaty establishing the European Atomic Energy Community, the conclusion of the Association Agreement between the European Union and the European Atomic Energy Community and its Member States, of the one part, and the Republic of Moldova, of the other part, as regards matters falling proper to the EAEC.

The text of the Agreement is attached to the present Recommendation.

On the part of the Union, the legal basis for the conclusion of this Agreement is Article 217, in conjunction with Article 218(6)(a) and the second subparagraph of Article 218(8) of TFEU.

For the EAEC, the legal basis for this Agreement is Article 101 of the Treaty establishing the European Atomic Energy Community.

The attached proposal constitutes, together with the Commission decision on conclusion, the legal instrument for conclusion of the Association Agreement on behalf of the EAEC.

The fact that the Commission has submitted its proposal as an agreement between the Union and its Member States and the Republic of Moldova is related to the genesis of this agreement under the rules of the Treaty before the entry into force of the Treaty of Lisbon.

According to Article 102 of the Euratom Treaty, an Agreement may not enter into force for the EAEC until the Commission has been notified by the Member States that the agreement has become applicable in accordance with the provisions of their respective national laws.

## COUNCIL DECISION

**approving the conclusion by the Commission, on behalf of the European Atomic Energy Community, of the Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and the Republic of Moldova, of the other part**

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty establishing the European Atomic Energy Community, and in particular the second paragraph of Article 101 thereof,

Having regard to the recommendation from the Commission,

Whereas:

- (1) On 15 June 2009, the Council authorised the Commission to open negotiations with the Republic of Moldova for the conclusion of a new Agreement between the European Union and the Republic of Moldova to replace the Partnership and Cooperation Agreement.<sup>1</sup>
- (2) Taking into account the close historical relationship and progressively closer links between the Parties, as well as their desire to strengthen and widen relations in an ambitious and innovative way, the negotiations on the Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and the Republic of Moldova, of the other part (hereinafter "the Agreement"), were successfully finalised by the initialling of the Agreement on 29 November 2013.
- (3) The Commission proposes to the Council that the Agreement should be signed on behalf of the Union and applied on a provisional basis in accordance with Article 465 of the Agreement, pending its conclusion at a later date.
- (4) The Agreement also covers matters falling under Euratom competences, namely Article 77(i).
- (5) The signature and conclusion of the Agreement is subject to a separate procedure as regards matters falling under the Treaty on European Union and the Treaty on the Functioning of the European Union.
- (6) The Agreement should therefore also be concluded, on behalf of the European Atomic Energy Community, as regards matters falling under the Euratom Treaty.

- (7) According to Article 102 of the Euratom Treaty, the Agreement may not enter into force for the European Atomic Energy Community until the European Commission has been notified by the Member States that such agreement has become applicable in accordance with the provisions of their respective national laws.
- (8) The conclusion of the Agreement by the European Commission, acting on behalf of the European Atomic Energy Community, should be approved.

HAS ADOPTED THIS DECISION:

*Article 1*

The conclusion by the European Commission, on behalf of the European Atomic Energy Community, of the Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and the Republic of Moldova, of the other part, is hereby approved.<sup>2 3</sup>

*Article 2*

This Decision shall enter into force on the date following that of its adoption.
