- 1. The <u>General Secretariat of the Council</u> has been informed of the resignation of Ms Paloma LÓPEZ-IZQUIERDO BOTÍN as alternate member of the Management Board of the European Institute for Gender Equality in the government representatives category (for Spain).
- 2. Article 10 of Regulation (EC) No 1922/2006 of 20 December 2006<sup>1</sup> provides, inter alia, that the Council should appoint 18 members, as well as alternates, of the Management Board of the European Institute for Gender Equality for a period of three years.
