Whereas:

- (1) In accordance with Council Decision ... ^{1*}, the Arrangement between the European Union and the Republic of Iceland on the modalities of its participation in the European Asylum Support Office (the 'Arrangement') was signed on ... **, subject to its conclusion.
- (2) The Arrangement should be approved.
- (3) As specified in recital 21 of Regulation (EU) No 439/2010 of the European Parliament and of the Council², the United Kingdom and Ireland are taking part in and are bound by that Regulation.
