The opinion of the European Court of Auditors (ECA) was distributed to delegations for their information on 4 March 2014 before the Committee meeting.

The Presidency debriefed <u>the Committee</u> on the outcome of the informal trilogue held on 4 March 2014. The EP and the Commission could only support a figure of 0.8% for the annual adjustment in 2012, while there would be no adjustment for 2011 (0%).

Delegations exchanged views on these figures and examined the draft legislative texts. No agreement was reached and the issue was postponed until the subsequent <u>Committee</u> session on 7 March 2014.

An agreement was reached on 7 March 2014 on the draft legislative texts including the compromise figures for the annual adjustments in 2011 (0%) and 2012 (0.8%).

A confirmation letter is to be sent to the Chair of the JURI Committee on the same day. The

draft legislative texts will be finalised by the lawyer-linguists of both institutions in the coming days. The consultation of the ECJ and of the ECA (doc. 7340/14 issued on 6 March 2014) was successfully concluded and the Committee took note of these opinions.

The Netherlands indicated that it could not accept the compromise re 2012 and that it wishes that this position is accordingly registered at the time of the final vote for approval.

The following Commission statement is attached to the minutes:

"Having regard to the figure for the annual adjustment for 2012 and taking into account the concerns as to budget neutrality, the Commission commits to:

- covering all additional expenditure corresponding to the adjustment of remuneration and pension of 0,8% for 2012 (EUR 116 million) through redeployment of appropriations available to EU Institutions in the 2014 budget without any additional contribution from Member States; any related amendment to the 2014 budget shall not increase administrative expenditure under Heading 5 of the multiannual financial framework;
- taking into account the 2012 adjustment for the years 2015-2020, for which the estimate of net additional expenditure amounts to EUR 31 million per year. The Commission has taken note of the conclusions of the Council on budget guidelines of 18 February 2014 and commits to presenting budgets for administrative expenditure (Heading 5) between 2015 and 2020 that will remain well below the ceilings of the 2014-2020 multiannual financial framework (MFF);
- desisting from cases C-86/13 and C-248/13 before the Court of Justice regarding the adjustment of remuneration and pension in 2012.

It is recalled that the redeployment of appropriations within the approved 2014 budget is made possible following the transfer of appropriations originally available in the 2012 budget for remuneration and pension that were used instead to frontload other administrative expenditure. It is thus estimated that in total an amount of EUR 115 million for all Institutions is available for redeployment under Heading 5 and could be used to pay additional expenditure for salaries and pensions in 2014. In addition, it cannot be excluded at this stage that the Institutions will be able to identify further possibilities for redeployment, thus further reducing the need for re-deployment of appropriations in 2014.

The ceilings of Heading 5 of the 2014-2020 MFF adopted in 2013 took into account statistical adjustments of 1.7% in 2011 and 1.7% in 2012. The revised adjustment of remuneration and pension by 0% for 2011 and 0.8% for 2012 would lead to savings over the 2014-2020 period of around EUR 1.5 billion in terms of expenditure for remuneration and pension larger than anticipated, thus leaving significant unallocated margins under the expenditure ceilings. The additional savings will come on top of the savings of around EUR 2.8 billion already factored in the 2014-2020 MFF."

<u>The Committee</u> agreed to the text of the revised statement and forwarded it to Council for endorsement.

The Commission made the following statement:

"The Commission takes note that the Council endorses the Commission's intention to sign, on behalf of the European Union, a Joint Statement on efforts to promote sustainable fishing capacity management on the global scale with other interested partners.

However, the Commission is of the opinion that such endorsement is not legally required and cannot constitute a precedent since the Joint Statement at stake is a non-binding instrument which fully reflects an existing EU position and policy.

In that respect, the Commission is of the opinion that it is empowered by the Treaties, namely on the basis of Article 17 TEU, to sign this Joint Statement on behalf of the European Union."

Following a debriefing on the outcome of the informal trilogue on 4 March 2014, <u>the Committee</u> granted the Presidency, by unanimity, permission to send a letter to the European Parliament confirming the agreement reached.

The Commission, while accepting the enlargement of the scope of its proposal to provisions implementing also ICCAT Recommendation 13-08, indicated it would make a statement at the time of the adoption.

During MEPC 66, IMO Member States parties to MARPOL Annex VI will need to vote on whether the time limit for the Tier III NOx emission standards, laid down in MARPOL Annex VI, should be postponed from 2016 to 2021.

The Commission recalls that in line with ECJ jurisprudence, its proposal represents the point of departure for concerted Union action, underlines that Member States must act in accordance with that proposal and that they are bound by the duty of sincere cooperation under Article 4(3) TEU."

The Republic of Latvia notes that inconsistent or incorrect usage of legal terminology of such substantive importance leads to legal ambiguity and therefore creates the risk of disrupting legal parallelism amongst the language versions of the Directive. The Republic of Latvia notes that the term 'to be established' in analogous context appears in Article 49 of the Treaty on the Functioning of the European Union, where it is being translated into Latvian as 'izveidot'. The latter term 'izveidot' more precisely describes the act of being established covered by the Directive.

The Republic of Latvia intends to initiate the corrigendum procedure regarding the Directive in order to ensure consistent and correct use of terminology."
