	- Adoption of the Council's position

- 1. On 11 February 2014, the <u>Commission</u> submitted to the Council draft amending budget (DAB) No 1 to the general budget for 2014 regarding the following elements:
 - adjustments needed to implement the capital increase of the European Investment Fund to improve access to financing for small and medium-sized enterprises (SMEs);
 - technical adjustments in the budgetary structure following the adoption of the legal base
 for Horizon 2020 in December 2013;
 - technical adjustments in the budgetary structure following the adoption of the Council
 Regulation establishing the Shift2Rail Joint Undertaking in December 2013;
 - other technical amendments necessary to allow the implementation of the 2014 budget as agreed by the Conciliation Committee.

This DAB is budgetary neutral in terms of overall commitment and payment appropriations.

- 2. The <u>Budget Committee</u> examined the Commission proposal at its meetings on 19 February and 25 March 2014 and was able to accept it without any changes.
 - It concluded that the Council decision adopting the Council's position on this DAB should contain an additional paragraph in its sole Article stating that: "Following the judgement of the European Court of Justice of 11 July 1985 in joined cases 87, 130/77, 22/83, 9 and 10/84, the Council recalls that budgetary remarks are not binding and are without prejudice to existing provisions in legislative acts".
- 3. At the closure of its examination, the Budget Committee agreed, by a qualified majority, to suggest that the <u>Permanent Representatives Committee</u>:
 - advises the <u>Council</u> to:
 - confirm the agreement on DAB No 1/2014 and consequently adopt the Council's position on DAB No 1/2014 as set out in point 2;
 - instruct the Presidency to prepare the budgetary documents to be sent to the
 European Parliament and to approve the draft letter in Annex 2 to that effect;
 - have the Council's position, as set out in Annex 1, published in the Official
 Journal of the European Union;
 - agrees, by unanimity, to the use of the written procedure for this purpose.

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 314 thereof.

Having regard to the Treaty establishing the European Atomic Energy Community, and in particular Article 106a thereof,

Having regard to Regulation (EC, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union and repealing Council Regulation (EC, Euratom) No 1605/2002¹ and in particular Article 41 thereof,

Whereas:

- the Union's budget for the financial year 2014 was definitively adopted on 20 November 2013²,
- on 11 February 2014, the Commission submitted a proposal containing draft amending budget No 1 to the general budget for the financial year 2014,

Sole Article
