1. The General Secretariat of the Council has been informed by the Croatian Government of its decision to nominate Ms Katarina GRGEC as its member in the category of Government representatives on the CEDEFOP Governing Board.
  
2. The General Secretariat of the Council has been informed by the Commission of the designation of a new member in the category of representatives of Employees' organisations:

3. The General Secretariat of the Council has been informed by the Commission of the designation of new members in the category of representatives of Employers' organisations:

4. Under Article 4 of Regulation (EEC) No 337/75<sup>1</sup>, as amended by Regulation (EC) No 2051/2004, members of the Governing Board, except for the Commission's representatives, are appointed by the Council for a period of three years.

COUNCIL DECISION  
of  
appointing and replacing members of the Governing Board  
of the European Centre for the Development of Vocational Training

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EEC) No 337/75 of 10 February 1975 establishing the European Centre for the Development of Vocational Training, and in particular Article 4 thereof <sup>1</sup>,

Having regard to the nomination submitted by the Croatian government,

Having regard to the nomination submitted by the Commission in the category of Employees' representatives,

Whereas:

- (1) By its Decision of 16 July 2012 <sup>2</sup>, the Council appointed the members of the Governing Board of the European Centre for the Development of Vocational Training for the period from 18 September 2012 to 17 September 2015.
- (2) The seat of the Croatian member had to be filled.
- (3) A member's seat is available for Spain on the Governing Board of the Centre in the category of Employees' representatives.

- (5) A member's seat on the Governing Board of the Centre in the category of representatives of Employers' organisations had to be filled for Croatia.
- (6) The members of the Governing Board of the aforementioned Centre should be appointed for the remainder of the current term of office, which expires on 17 September 2015.
