d) Detailed grounds for the increase

On 16 December 2013, the Council decided to conclude on behalf of the European Union the Protocol between the European Union and the Kingdom of Morocco setting out the fishing opportunities and financial contribution provided for in the Fisheries Partnership Agreement between the European Union and the Kingdom of Morocco (Decision 2013/785/EU).

Pursuant to this Decision, as soon as Morocco has notified the EU of the completion of the internal procedures necessary for the Protocol to enter into force, EU vessels may resume fishing activities in the Moroccan fishing zone under the new Protocol. The EU is committed to pay the financial contribution as soon as the new Protocol enters into force.

Morocco is expected to ratify the new Protocol before the end of March 2014. The budget allocation will be needed on operational line 11 03 01 in good time in order to make the commitments and payments arising from the above-mentioned legal basis, taking into account the 90-day deadline for payment.
