1. The Commission submitted the above delegated acts to the Council in accordance with the procedure set out in Article 290 TFEU and with Article 227(5) of Regulation (EU) No 1308/2013 of the European Parliament and of the Council establishing a common organisation of the markets in agricultural products<sup>1</sup>. The Commission having notified the delegated acts to the EP and Council on 11 March 2014, the Council may object to any of them until 10 May 2014.
2. The Special Committee on Agriculture (SCA) at its meeting on 2 April 2014 examined the delegated acts and took note of the objection raised by Latvia and the United Kingdom on the Commission Delegated Regulation mentioned above under e). No objections were noted on the other four delegated acts. The SCA further noted the parliamentary scrutiny reserves entered by Denmark and the Netherlands as well as the scrutiny reserve entered by Austria on all of the CAP Reform delegated acts<sup>2</sup> and of the intention of those delegations to lift their reserves as soon as possible. In this light the SCA noted the absence of a qualified majority in Council to object to any of the five delegated acts.
3. It is therefore suggested that the SCA recommend to Council that it confirms that it has no intention to object to the five delegated acts and that the Commission and the European Parliament be informed thereof. This implies that, unless the European Parliament objects, the delegated acts shall enter into force in accordance with Article 227(5) of Regulation EU (No) 1308/2013.
