During the Jurists/Linguists Group of 6 May 2014, only the text of the base language (EN) will be discussed and finalised. On that basis, and taking into account the accepted comments, the other language versions will be aligned.

Due to exceptional circumstances and the tight deadline for comments, a meeting will take place on 7 May 2014 during which each language version is to be examined by the national expert/s and the Jurists/Linguists of the language concerned, on the basis of the EN version agreed upon the day before (the EN version is therefore not concerned).

The presence of experts at the meeting is desirable.

Your attention is drawn to the following:

- Paper copies of documents will no longer be provided in the meeting room. You should therefore ensure that you have the latest version of the text to be discussed at the meeting.
- In order to ensure the smooth running of the meeting, it is essential that all delegates follow the specific pagination of the text of the base language. In addition, please ensure that you use the version containing track changes and that you remove the "balloon view" function.
