On the basis of document 8874/14, the SCA examined the Cyprus request to object to article 1 of the delegated regulation.

The Cyprus delegation reiterated the argumentation presented in the Council Working Party on 10 April, and reminded the letter sent to the Commission on 23 September 2013, before the adoption of the draft delegated regulation by the College, by 8 Ministers of Agriculture (CY, FR, IT, MT, ES, RO, EL, PT).

The SCA took note that there was no qualified majority to object to the delegated act and that no action was needed at Council level.

Following the request of the Cyprus delegation to have in a near future a debate on the management of delegated acts in the light of the recent Council Legal Service opinion (doc. 8574/14), the Presidency announced that it will react on this issue.

6. **Organisation of future work**

The Presidency confirmed that the next meeting of the SCA will take place on 28 April 2014.
