### I. INTRODUCTION

On 5 February 2014, the Parliament voted to adopt 78 amendments to the abovementioned proposal for a Regulation, but did not at that sitting adopt its legislative resolution, thereby not closing the first reading and leaving open the possibility of reaching an agreement in first reading<sup>1</sup>. The matter was then referred back to the Committee on International Trade pursuant to Rule 57(2) of the European Parliament's Rules of Procedure.

No such agreement was reached and the Parliament decided to proceed to vote on the legislative resolution, thereby closing its first reading.

#### II. **VOTE**

On 16 April 2014, the plenary voted to adopt its legislative resolution, adopting as its first-reading position the 78 amendments it had adopted on 5 February 2014.

The legislative resolution is set out in the Annex.

# Protection against dumped and subsidised imports from countries not members of the EU \*\*\*I

European Parliament legislative resolution of 16 April 2014 on the proposal for a regulation of the European Parliament and of the Council amending Council Regulation (EC) No 1225/2009 on protection against dumped imports from countries not members of the European Community and Council Regulation (EC) No 597/2009 on protection against subsidised imports from countries not members of the European Community (COM(2013)0192 - C7-0097/2013 - 2013/0103(COD))

(Ordinary legislative procedure: first reading)

The European Parliament,

- having regard to the Commission proposal to Parliament and the Council (COM(2013)0192),
- having regard to Article 294(2) and Article 207(2) of the Treaty on the Functioning of the European Union, pursuant to which the Commission submitted the proposal to Parliament (C7-0097/2013),
- having regard to Article 294(3) of the Treaty on the Functioning of the European Union,
- having regard to Rule 55 of its Rules of Procedure,
- having regard to the report of the Committee on International Trade (A7-0053/2014),
- 1. Adopts as its position at first reading the text adopted on 5 February 2014<sup>1</sup>;
- 2. Calls on the Commission to refer the matter to Parliament again if it intends to amend its proposal substantially or replace it with another text;
- 3. Instructs its President to forward its position to the Council, the Commission and the national parliaments.
