d) <u>Detailed grounds for the increase</u>

On 3 December 2012 the Council adopted the Decision on the signing and provisional application for a period of two years of the Protocol to the Partnership Agreement with the Islamic Republic of Mauritania (Council ref. 2012/827/EU). Under this Decision the European Union is committed to paying a financial contribution.

The European Parliament gave its consent to the conclusion of the Protocol during its plenary sitting on 8 October 2013 (ref. 15777/2012 – C7-0419/2012 – 2012/0258(NLE)).

The budget allocation is therefore needed in operational line 11 03 01 in order to make the commitments and payments arising from the abovementioned legal base. A total of EUR 70 000 000 in commitment appropriations is planned for 2013.

However, given the deadlines set for implementation of the sectoral support component of the Protocol, the corresponding amount of EUR 3 000 000 will not be paid until 2014. A total of EUR 67 000 000 in payment appropriations is planned for 2013.

d) <u>Detailed grounds for the decrease</u>

The balance of commitment and payment appropriations currently available in the reserve line for international fisheries agreements is sufficient to cover the increase in the operational line.

EUR 42 030 000 in commitment appropriations and EUR 43 695 651 in payment appropriations will not be used. A request to transfer the payment appropriations was made in draft amending budget DAB8/2013.

The balance remaining in the reserve could cover possible requirements under the fisheries agreements with Mauritius, Cape Verde and Kiribati.
