"Several Member States and MEPs have highlighted that certain island and outermost regions have specific characteristics, both geographically and in terms of the economic dependence caused by their distance, remoteness, and small markets, which make them particularly vulnerable to the effects of natural disasters. In these regions, any natural disaster has an aggravated impact and there is a greater need for assistance.

Malta and Cyprus support that special treatment for certain type of regions is well safeguarded and recall that Article 174 of the TFEU, the related Declaration (33) and paragraphs 44 and 51 of the European Council conclusions of 7-8 February 2013 recognise the specific character of Island Member States.

Malta and Cyprus consider that the regional threshold exists to facilitate the ability of smaller regions to access the Fund and our position remains that the situation of Island Member States such as Malta and Cyprus, and the vulnerability of such territories to natural disasters should be reflected in the legislative proposal."

98. Preparation of the Council meeting (Foreign Affairs/Trade) on 8 May 2014

EU-Canada CETA negotiations a)

State of play

The Commission confirmed its aim to finalise the negotiations and to initial the text of the draft agreement with Canada by 7 May 2014, thus enabling the Commissioner to present a "consolidated package" to the Council on 8 May 2014; considering that the final full consolidated text would not be made available at the same time, Ministers would not be asked to take any position in that respect. In case the finalisation of the negotiations would not be possible the Commissioner intended only to present to the Council the state of play in the negotiations.

Following the discussion, the Presidency concluded that the Committee had taken note of the Commission's assessment of prospects and timing for the possible initialling of the draft agreement and its expectations for the ministerial discussion on 8 May 2014. The Committee and the Presidency had taken good note of delegations' comments on mixity and the "mirror clause" (reservation on investment screening). The Presidency had expressed its expectation that delegations would be informed well in advance of the initialling and stressed that delegations expected to receive the final full consolidated text as soon as possible so as to be able to scrutinise it before the initialling.

The Council Legal Service clarified certain aspects regarding the possible initialling.

b) **EU-Japan FTA negotiations**

State of play

The Presidency explained the aims of the Council discussion. The Commission confirmed that its report on fulfilment of Japan's commitments on elimination of non-tariff barriers and opening up of government procurement would be adopted only in mid-May; therefore, the Council discussion would be based on the Commissioner's oral presentation and some elements of the Commission's assessment that had already been shared with delegations.

c) DDA: Post-Bali agenda and the green goods initiative

The Presidency explained the aims of the Council discussion on the post-Bali agenda (on the basis of the Commission's background note made available in document 9224/14) and the green goods initiative.

While welcoming the delegations' strong support for the green goods initiative and the adoption of the Council conclusions, the Commission voiced its disagreement with the parallel adoption of the negotiating directives and announced its intention to enter on this matter a statement to the Council minutes.

The Presidency concluded that the Committee had reached an agreement on the texts of the draft Council conclusions (doc. 9223/14) and the draft negotiating directives (doc. 9221/14 EU RESTRICTED), which would be submitted for formal adoption as a false "B" item to the Foreign Affairs Council (Trade) on 8 May 2014.

d) Other items in connection with the Council meeting

The Commission explained the Commissioner's intentions regarding two items under "Any other business" (state of play of EPA negotiations; state of play in implementation of trade preferences by third countries having FTAs with the EU to Croatia) and the lunch item (EU-US TTIP negotiations). The Croatian delegation thanked for accommodating its request for an AOB item, noting that its explanatory note (doc. 9373/14) had been made available before the Committee meeting.

In the light of the debate, it was agreed that the Committee would hold an extraordinary meeting on 5 May 2014 to discuss a compromise proposal, to be circulated on 2 May 2014, for amending the existing legal criteria for the listing of persons and/or entities subject to restrictive measures.

Furthermore, the Committee took note of a revised Commission reflection paper on the "Legal Consequences of the Illegal Annexation of Crimea by the Russian Federation and Proposals for Economic, Trade and Financial Restrictions", which had been revised following comments received from Member States. The Commission also distributed to delegations revised country fiches on the impact of stage 3 restrictive measures, following comments submitted to the Commission by the respective Member States.

At its meeting on 5 May 2014, the Committee discussed the revised proposal presented by the European External Action Service regarding amending the existing legal criteria for the listing of persons and/or entities subject to restrictive measures. It was agreed that the Committee would continue the discussion at its meeting on 7 May 2014, on the basis of a further revised proposal to be prepared by the European External Action Service.

• Case of Italian marines on trial in India

Italy updated the Committee on recent developments in the case of two Italian marines detained in India since 2012, informing that the case had entered a new phase: an official note had been sent to Indian authorities with a view to finding a solution, including by using mechanisms available under the international law.
