Others asked the Commission for some clarifications on various matters.

<u>The Presidency</u> noted the reservations raised by these delegations and indicated that it would table this item at the SCA on 2 June 2014 with the aim of agreeing on a draft Council Decision to be subsequently adopted at the June "Agriculture and Fisheries" Council. In the meantime, the Presidency would reflect on the appropriate wording related to the special Committee mentioned in Article 3 of the Council Decision.
