- 1. The <u>General Secretariat of the Council</u> has been informed by the French Government of its decision to nominate Ms Brigitte DORIATH as its member in the category of Government representatives on the CEDEFOP Governing Board, replacing Mr Jean-Marc HUART.
- 2. Under Article 4 of Regulation (EEC) No 337/75<sup>1</sup>, as amended by Regulation (EC) No 2051/2004, members of the Governing Board, except for the Commission's representatives, are appointed by the Council for a period of three years.

# THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EEC) No 337/75 of 10 February 1975 establishing the European Centre for the Development of Vocational Training, and in particular Article 4 thereof <sup>1</sup>,

Having regard to the nomination submitted by the French government,

#### Whereas:

- (1) By its Decision of 16 July 2012 <sup>2</sup>, the Council appointed the members of the Governing Board of the European Centre for the Development of Vocational Training for the period from 18 September 2012 to 17 September 2015.
- (2) A member's seat is available for France on the Governing Board of the Centre in the category of Government representatives as a result of the resignation of Mr Jean-Marc HUART.
- (3) The members of the Governing Board of the aforementioned Centre should be appointed for the remainder of the current term of office, which expires on 17 September 2015.
