# DECISION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL

on the mobilisation of the EU Solidarity Fund

#### EXPLANATORY MEMORANDUM

Council Regulation (EU, EURATOM) No 1311/2013 of 2 December 2013 laying down the multiannual financial framework for the years 2014-2020<sup>1</sup>, and in particular the Article 10 thereof allows for the mobilisation of the European Union Solidarity Fund, within an annual ceiling of EUR 500 million (2011 prices), over and above the relevant headings of the financial framework.

Point 11 of the Interinstitutional Agreement of 2 December 2013 between the European Parliament, the Council and the Commission on budgetary discipline, on cooperation in budgetary matters on and sound financial management<sup>2</sup> set of the modalities for the mobilisation of the Fund.

The conditions of eligibility to the Fund are detailed in the Regulation of the European Parliament and the Council, amending Council Regulation (EC) No 2012/2002<sup>3</sup>, which foresees that an amount of up to a maximum of EUR 50 000 000 in both commitment and payment appropriations shall be included in the budget for the payment of advances.

The Commission shall include these amounts in the Draft Budget 2015.

#### DECISION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL

#### on the mobilisation of the EU Solidarity Fund

#### THE EUROPEAN PARLIAMENT AND THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Regulation of the European Parliament and the Council, amending Council Regulation (EC)  $N^{\circ}$  2012/2002 of 11 November 2002 establishing the European Union Solidarity Fund<sup>4</sup>, and in particular Article 4a(4) thereof,

Having regard to the Interinstitutional Agreement of 2 December 2013 between the European Parliament, the Council and the Commission on budgetary discipline, on cooperation in budgetary matters and on sound financial management<sup>5</sup>, and in particular point 11 thereof,

Having regard to the proposal from the European Commission,

#### Whereas:

- (1) The European Union has created a European Union Solidarity Fund (the "Fund") to show solidarity with the population of regions struck by disasters.
- (2) Article 10 of Regulation (EU, Euratom) N° 1311/2013 allows the mobilisation of the Fund within the annual ceiling of EUR 500 million (2011 prices).
- (3) Article 4a(4) of amended Regulation (EC) N°2012/2002 foresees that an amount of EUR 50 000 000 is made available for the payment of advances through appropriations in the general budget of the Union.

#### HAVE ADOPTED THIS DECISION:

#### Article 1

For the general budget of the European Union for the financial year 2015, the European Union Solidarity Fund shall be mobilised to provide the sum of EUR 50 000 000 in commitment and payment appropriations.
