<u>The SCA</u> supported the revised draft Council Decision as prepared by the Presidency and invited the Council to adopt it at the "Agriculture and Fisheries" Council on 16/17 June under an A-item.

<u>The SCA</u> took note of the reserves entered by delegations, as well as the comments made by the Commission on the Presidency text. <u>The SCA</u> further took note of the <u>Presidency</u>'s intention to present a further revised version with a view to adoption by Council ("Agriculture and Fisheries") of the conclusions at its session on 16-17 June 2014.

The SCA further took note of the request of the <u>Hungarian delegation</u>, supported by <u>Bulgaria</u>, <u>Croatia</u>, <u>Latvia</u>, <u>Lithuania</u>, <u>Poland</u>, <u>Portugal</u>, <u>Romania</u>, <u>Slovenia</u> and <u>Slovakia delegations</u>, to enter a common declaration in the Council minutes.

The SCA finally noted that <u>Denmark</u> maintained a parliamentary scrutiny reserve.
