being parties to the Treaty on European Union and the Treaty on the Functioning of the European Union and being Member States of the European Union (hereinafter 'the Member States'),

and

THE EUROPEAN UNION,

of the other part;

Having regard to the accession of the Republic of Croatia to the European Union on 1 July 2013,

HAVE AGREED AS FOLLOWS:

Article 1

The Republic of Croatia is a Party to the Euro-Mediterranean Aviation Agreement signed by the government of the State of Israel and the European Union and its Member States on 10 June 2013 (hereinafter 'the Agreement').

Article 2

The text of the Agreement in the Croatian language, which is attached to this Protocol, shall become authentic under the same conditions as the other language versions.

Article 3

- 1. This Protocol shall be approved by the Parties in accordance with their internal procedures and legislation. It shall enter into force on the date of entry into force of the Agreement. However, should this Protocol be approved by the Contracting Parties after the date of entry into force of the Agreement, it would then enter into force in accordance with Article 30(2) of the Agreement.
- 2. This protocol shall be an integral part of the Agreement and shall be applied on a provisional basis as from signature thereof by the Parties.

Done at, in duplicate, on 2014, in the Bulgarian, Croatian, Czech, Danish, Dutch, English, Estonian, Finnish, French, German, Greek, Hungarian, Italian, Latvian, Lithuanian, Maltese, Polish, Portuguese, Romanian, Slovak, Slovene, Spanish, Swedish and Hebrew languages, each text being equally authentic.
