Statement by Germany

1. Regarding the second bullet point under "The Council of the European Union stresses that", on page 3: In accordance with the conclusions of the European Council, the use of a broader range of indicators from the scoreboard of social indicators aims at achieving a broader understanding of social developments. The scoreboard and its indicators must be developed further on an ongoing basis.
2. Regarding the fourth bullet point of page 8: EMCO's mandate is set out in Article 150 TFEU. EMCO has no mandate for action in the context of monitoring economic policies under Article 121. The arrangements provided for in the macroeconomic imbalance procedure must be fully complied with.
3. At the European Council meeting in December 2013 it was agreed that the European Council would decide on the next steps to strengthen coordination of economic policies through contractual arrangements at its meeting in October 2014. This process should not be prejudged.
