EU Diplomatic Representation in third countries – Second half of 2014

1. Article 221 of the TFEU states that:
 - "1. Union delegations in third countries and at international organisations shall represent the Union.
 2. Union delegations shall be placed under the authority of the High Representative of the Union for Foreign Affairs and Security Policy. They shall act in close cooperation with Member States' diplomatic and consular missions."

2. The Council Decision establishing the organisation and functioning of the European External Action Service of 26 July 2010 states in Article 1 that: "The EEAS shall be made up of a central administration and of the Union Delegations to third countries and to international organisations" and that "The EEAS shall assist the President of the European Council, the President of the Commission, and the Commission in the exercise of their respective functions in the area of external relations."
It also states in article 3 that " The EEAS shall support, and work in cooperation with, the diplomatic services of the Member States, as well as with the General Secretariat of the Council and the services of the Commission, in order to ensure consistency between the different areas of the Union's external action and between those areas and its other policies."

3. The responsibility of representation and coordination on behalf of the EU has been performed by a number of Union delegations as of 1 January 2010 or later.

4. As regards the representation of the EU in the remaining third countries, the Council decision of 20 December 2006 on the "Arrangements establishing a system according to which Member States are to take on the functions of the Presidency in third countries" ¹ will continue to apply. These arrangements are set out **in Annex I** to this note and are based on the order in which Member States exercise the Presidency of the Council (Council Decision 2007/5/EC, Euratom, OJ L 1, 4.1.2007, p.11).
5. The latter arrangements are without prejudice to the special provisions governing Luxembourg's representation abroad by either Belgium or the Netherlands, depending on the case.
6. On the basis of the above, the EEAS has compiled :
- **in Annex II**
3 lists indicating the 3rd countries where the EU Diplomatic Representation is performed by :
 - 1) an accredited and resident EU Representation
 - 2) an accredited but not resident EU Representation
 - 3) a Member State. This overview sets out the arrangements for the EU Diplomatic Representation during the second semester of 2014 (1st column) together with an indicative list of EU Representation in the first half of 2015 (2nd column).
 - **in Annex III**
a list of Member States' diplomatic posts with a resident accredited representation in third countries.²

**Arrangements decided in 2006 which will continue to apply
during the 2nd semester of 2014**

**"Arrangements establishing a system according to which Member States
are to take on the functions of the Presidency in third countries**

In order to ensure a uniform procedure regarding the representation of the Presidency in third countries and to deal with the possibility of the MS holding the office of Presidency not being represented in a third country by a resident representative, the following arrangements will apply:

- (a) in third countries where the Member State providing the Presidency has an accredited resident representative, he/she will exercise the functions of the Presidency;
- (b) in third countries where the Presidency does not have an accredited representative, or where its accredited representative is resident in another capital and is not in a position to perform the functions of the Presidency on the spot, these functions will be performed by the representative of the Member State which will occupy the Presidency for the following six months;
- (c) where neither the Presidency nor the succeeding Presidency has a resident accredited representative, the European Union will be represented in rotation, for a period of six months, by another Member State represented in the country following the order in which Member States are to exercise the Presidency of the Council, as established by the Council.

This rotation will continue until the arrangements set out in (a) or (b) above become applicable again. Once they are no longer applicable the same rotation will resume where it stopped;

- (d) where, in a given situation, it would be in the interest of the European Union or the European Community and the Member States represented in the country, to alter the arrangements set out above, either the Foreign Ministries or the resident representatives of those Member States could make a recommendation to this effect which would be communicated to all Member States by the Council Secretariat;
 - (e) where, under the above arrangements, a Member State other than the Presidency exercises the functions of the Presidency, it will ensure that there is close liaison with the Presidency."
