## Notification by the Republic of Cyprus pursuant to Article 29(2)

In accordance with Article 29(2) of the Framework Decision, the Republic of Cyprus hereby transmits to the European Commission and to the General Secretariat of the Council the text of the national legislation, Law No 67(I)/2014, transposing the above Framework Decision into national law.

Law No 67(I)/2014 entered into force on 23 May 2014 upon its publication in the Official Gazette of the Republic.

## Notification pursuant to Article 2(1)

The competent authorities of the Republic of Cyprus are:

- 1. When the Republic of Cyprus is the issuing State, the authority competent for issuing judgments in the Republic of Cyprus is the assize court or district court which issued the judgment.
- 2. When the Republic of Cyprus is the executing State, the authority competent for enforcement is the district court within the territorial jurisdiction of which the person against whom another Member State has issued a judgment has his or her habitual residence.

Furthermore, the Republic of Cyprus hereby notifies the European Commission and the General Secretariat of the Council of the European Union that the Ministry of Justice and Public Order is the authority competent for receiving and transmitting transit requests.
