Subject:	Initiative aimed at collecting best practices for passenger and baggage control in railways

### **Introduction**

One of the major challenges for police forces is to manage the high number of passengers and baggage on board trains and in stations. The distinctive "open" railway system does not permit the adoption of solutions already implemented in the airport sector, except in restricted areas. Authorities are therefore currently facing both the need not to hinder the regular flow of passengers and the need to guarantee effective prevention and control. Consequently, it is essential to look for solutions that make it possible to combine these two aspects, which are also fundamental to guarantee that citizens feel safe.

## **Description of the initiative**

#### **Objectives**

The aim of the initiative is to collect and study the best practices established by Member States in the control of passengers and baggage on board trains and in stations so as to improve the practices adopted in order to obtain high safety standards, at the same time keeping unchanged the characteristic feature of the rail transport sector which is, by definition, open. It includes an operational stage envisaging a European action day to increase the perception of security.

d. collation of the results of the European Action Day;

e. compiling of answers and results;

f. presentation of the final draft report on the outcome of the questionnaire and of the European

Action Day for approval by the LEWP.

**Outcome:** 

The final report containing the best practices will be shared with all Member States in order to

facilitate finding solutions which, through the implementation of certain measures and methods,

may help reach a suitable compromise between safety and accessibility of railroad transport.
