- 1. On 29 June 2011, the Commission submitted to the Council the proposal and the draft Interinstitutional Agreement mentioned in the subject.
- 2. On 6 July 2012, the Commission submitted an amended proposal for a Council Regulation laying down the multiannual financial framework for the years 2014-2020.

- On 4 September 2013, the Commission approved the draft Interinstitutional Agreement as set out in document 11298/13 POLGEN 117 CADREFIN 154, subject to legal-linguistic finalisation, and the draft declarations as set out in document 11961/13 ADD 1 POLGEN 135 CADREFIN 180.
- 4. On 19 November 2013, the European Parliament gave its consent to the draft Council Regulation laying down the multiannual financial framework for the years 2014-2020 as set out in document 11791/13 POLGEN 129 CADREFIN 170 (and its successive revisions in ET, SL, PT, FR, BG and DE) + COR 1, approved the draft Interinstitutional Agreement between the European Parliament, the Council and the Commission on budgetary discipline, on cooperation in budgetary matters and on sound financial management as set out in document 11838/13 POLGEN 130 CADREFIN 172 and approved the draft joint declarations as set out in document 11961/13 ADD 1 POLGEN 135 CADREFIN 180.
- 5. <u>The Permanent Representatives Committee</u> is therefore invited to advise the Council to:
  - adopt the Council Regulation laying down the multiannual financial framework for the years 2014-2020 as set out in document 11791/7/13 REV 7;
  - approve the Interinstitutional Agreement between the European Parliament, the Council
    and the Commission on budgetary discipline, on cooperation in budgetary matters and
    on sound financial management as set out in document 11838/13 POLGEN 130
     CADREFIN 172;
  - approve the joint Declarations and agree to enter in the Council minutes the
     Declarations, as set out in the addendum to this note.
