On 11 March 2014, I wrote to Mr KOURKOULAS, President-in-Office of the Council, to inform the Council that the European Parliament has authorised the sending of a ten-Member ad hoc delegation to the high level segment of the 20th Conference of the Parties to the United Nations Framework Convention on Climate Change.

At its on 15 July 2014, the Conference of Presidents agreed to increase the size of that delegation 12 Members.
