Dear Mr Corsepius,

I have the pleasure to present to you my sincere compliments and to inform you of the proposal of the Government of the Republic of Bulgaria for a new Bulgarian alternate member of the Committee of the Regions. Ms Kornelia Marinova, Chair of the Municipal Council of the Municipality of Lovech was elected member of the 42nd National Assembly of Bulgaria in 2013 as a result of which her local authority electoral mandate was terminated. By Decision № 458 of 03.07.2014 the Council of Ministers of the Republic of Bulgaria has proposed Ms Madlena Boyadzhieva, Chair of the Municipal Council of the Municipality of Teteven as an alternate member of the Committee of the Regions replacing Ms Marinova. Holding a local authority electoral mandate Ms Boyadzhieva meets the requirements of Art. 300 (3) of the Treaty on the function of the European Union for becoming a Committee of the Regions alternate member.
