**Subject: Appointment of Greek representatives to the Committee of the Regions
for the remainder of the current mandate**

Your Excellency,

Following the regional and municipal elections of May 2014 in Greece, I hereby submit to you the names of the new candidates proposed by the Greek Government in substitution of those Greek members and alternate members whose mandate has either expired or changed for the remainder of the current CoR mandate.

As a result of the aforementioned elections the mandate of 20 out of 24 members and alternate members of the Greek CoR delegation has either expired or changed. Amongst the 4 members whose mandate has remained unchanged, Mr Ioannis BOUTARIS (Mayor of Thessaloniki) has resigned from the post of full member and is to be nominated alternate member.

I would also like to point out that Mr Dimitrios KALOGEROPOULOS, advisor to the Municipality of Maroussi is politically accountable to the elected Municipal Council of Maroussi by virtue of the latter's decision.


