Given that the Task Force and the Sherpa Committee were set up by the European Council, the General Secretariat of the Council has treated your request as being addressed to the European Council, thus acting as secretariat for the European Council pursuant to Article 235(4) of the Treaty on the Functioning of the European Union; it has therefor examined your request on the basis of Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents¹ (hereafter the "Regulation") and specific provisions of the European Council's Rules of Procedure².

Article 10(2) of the European Council's Rules of Procedure (European Council Decision 2009/882/EU; Official Journal L 315 of 2.12.2009, p. 51) makes Annex II to the Council's Rules of Procedure (Council Decision No 2009/937/EU; Official Journal L 325, 11.12.2009, p. 35) applicable mutatis mutandis.

Concerning part 3 of your request, in addition to the 23 documents sent to you on 1 July 2014, the following documents have been identified:

- German contribution of 24 September 2010
- Romanian contribution of 1 June 2010

Having been consulted by the General Secretariat, the German and Romanian authorities have argued that release of the specific comments contained in their respective contributions would severely affect future decision-making issues of the same kind. They indeed contain opinions that were put forward for internal use only, as part of deliberations and preliminary consultations within the Task Force and the Sherpa Committee. Taking into account the delegations' arguments, the General Secretariat has come to the conclusion that release of these documents would seriously undermine the decision-making process within the European Council and its preparatory bodies. As there is no evidence suggesting an overriding public interest to warrant disclosure of the documents in question, the General Secretariat has concluded that protection of the decision-making process outweighs the

public interest in disclosure.

Accordingly, pursuant to Article 4(3), of the Regulation (protection of the decision-making process), the General Secretariat is unable to accede to your request for access to these two documents at this stage.

The General Secretariat has also looked into the possibility of disclosing parts of the documents pursuant to Article 4(6) of the Regulation. However, as the information contained in each of the documents forms an inseparable whole, partial access cannot be granted either at present.

Statutory remedy notice

Pursuant to Article 7(2) of the Regulation, you may submit a confirmatory application requesting the European Council to reconsider this position, within 15 working days of receiving this reply¹.

Dear Sir,

Pursuant to Article 7(2) of Regulation 1049/2001, I hereby would like to make a confirmatory application for two documents, the German contribution of 24 September 2010 and the Romanian contribution of 1 June 2010 to the European Council's 'Task Force' on economic governance, which fall into part three of my request for documents Ref. 14/1028-ws/dm. On the 17 September I received a number of documents that I had requested along with a letter outlining why the Council was unable to release the German and Romanian contributions to the 'Task Force'. The letter stated that:

the release of these documents would seriously undermine the decision-making process within the European Council and its preparatory bodies. As there is no evidence suggesting an overriding public interest to warrant disclosure of the documents in question, the General Secretariat has concluded that protection of the decision-making process outweighs the public interest in disclosure.

However according to Article 4(3) of Regulation No 1049/2001 documents can only be denied "where the decision has not been taken by the institution". Yet the European Council, as a whole, signed off on the recommendations by the 'Task Force'. See report entitled 'Strengthening Economic Governance in the EU'. Further those recommendations were the basis for two legislative packages known as the 'Sixpack' and 'Two-pack', which were approved by the Council of Ministers and European Parliament. The argument put forward that the "protection of the decision-making process outweighs the public interest in disclosure" is not valid either. If we are to understand how the 'Task Force' arrived at its recommendations, then there is a need to know all of the arguments that were put forward by every member state delegation. As those recommendations helped to shape the EU's response to the financial crisis, thus impacting on the lives of citizens across the union, the public interest in knowing how the decisions to fight the crisis were made outweigh the "protection of the decision-making process".

With this application, I invite the Council to review its position and grant me full access to the documents requested.
