#### 2. Presentation of the agenda of the Council meeting (Foreign Affairs) on 20 October 2014

The Committee took note of a presentation by the European External Action Service of the provisional agenda of the Council meeting (Foreign Affairs) on 20 October 2014. It was noted that the agenda would include Iraq and ISIL, Syria, Ebola, MEPP and Gaza, as well as possibly Libya and Ukraine.

#### **3. Ukraine** (restricted session)

The Committee took note of the presentation by the European External Action Service and the Commission of the implementation of the peace plan since the entry into force of the Minsk Agreement and Protocol.

Based on the positions expressed by delegations, it was agreed that the Presidency would inform the President of the European Council of the following:

- 1. Based on an assessment by the European External Action Service (EEAS) and the Commission, the Permanent Representatives Committee (COREPER) has carried out a comprehensive review of the situation in Eastern Ukraine.
- 2. The Committee shared the analysis that while encouraging developments have been registered in the political process and in the implementation of some aspects of the Minsk Protocol, relevant parts of the same protocol will need to be properly implemented. The European Union will continue to closely monitor developments on the ground and review the implementation of the Minsk Protocol. The EU recalls its full support to Ukraine's sovereignty and territorial integrity.
- 3. The EU has reiterated the central role played by the OSCE Special Monitoring Mission (SMM) and expressed its willingness, in particular, to provide the SMM with the necessary human and material support to fulfill its tasks.
- The EU is also committed to enhance its humanitarian and reconstruction efforts in 4. Eastern Ukraine.
- 5. The EU will continue to support the reform efforts in Ukraine, including through the implementation of the Association Agreement that constitutes the basis of the contractual relations between the Ukraine and the EU.
- 6. The EU will also pursue its proactive engagement with the parties to reach a peaceful solution of the crisis in Eastern Ukraine.

7. If the situation on the ground so warrants, the Commission and the EEAS would be invited to put forward to the Council proposals to amend, suspend or repeal the set of sanctions in force, in all or in part.

<u>The Committee</u> decided to remain seized of the matter and discuss it again before the end of October.

#### 4. Debrief of the EU-Canada Summit (Ottawa, 26 September 2014)

<u>The Committee</u> was debriefed by the EEAS and the Commission on the outcome of the EU-Canada Summit held in Ottawa, on 26 September 2014. The Summit was described as a milestone stablishing a strong partnership between the European Union and Canada. In addition, both presidents participated at the Toronto business event.

Both parties celebrated the end of negotiations of the Comprehensive Economic Trade Agreement (CETA) and the Strategic Partnership Agreement (SPA). Other topics were also discussed, such as visa reciprocity, Ukraine, climate change, the Arctic and energy cooperation.

## 5. Follow-up to the Council meeting (General Affairs) on 29 September 2014

The Committee took note of the key outcomes of this Council meeting.

#### 6. Presentation of the agenda of the Council meeting (General Affairs) on 21 October 2014

<u>The Committee</u> took note of the agenda of the October General Affairs Council which will include the following items:

- preparations of the October European Council draft EC conclusions;
- Council conclusions on the governance of macro regional strategies;
- EC follow-up: strategic priorities Europe of Freedom, Security and Justice.

#### 7. 10th ASEM Summit (Milan, 16-17 October 2014)

<u>The Committee</u> approved the state of play of the preparations for the 10th ASEM Summit (16-17 October 2014, Milan) on the basis of a background note (doc. 13507/14 LIMITE) and provided guidance on open issues in the draft Chair's statement.

#### 8. Ebola

The Commission gave a state of play on the situation and on the many actions taken in the EU to address the Ebola crisis in West Africa, highlighting the role played by the ERCC as a service provider/hub for information exchanges, open to the relevant Commission and EEAS services and MS authorities. The EEAS stressed the need to consider military capabilities, which have their specificities and channels. It is required to look at all possible solutions to the existing gaps and conduct prudent planning in the light of growing security and economic problems and the need to strengthen coordination.

MS interventions focused on key contributions provided or planned, the issue of transportation, including medical evacuation of affected healthcare personnel and the requirement to find practical solutions for reinforced coordination.

The Presidency announced that, with the support of the Commission, the EEAS and the GSC, it will bring together the different elements on the table in a single coherent framework paper based on a light coordination mechanism. This should feed the discussion in preparation of the October European Council.

<u>The Committee</u> will revert to this issue at its next meeting.

# 9. Preparation of the Council meeting (Economic and Financial Affairs) on 14 October 2014

- Other items in connection with the Council meeting

<u>The Committee</u> reviewed the state of readiness of the agenda items listed.

Only comment from DK on whether there would be a basis (paper, steering note) for the discussion on Climate change. Presidency informed that there would be no Presidency paper.

#### 47. Preparation of the Council meeting (Justice and Home Affairs) on 9/10 October 2014

a) Taking action to better manage migratory flows

<u>The Committee</u> confirmed the outcome of the discussions held during the Mixed Committee (see doc. 14116/14 JAI 759 COMIX 541).

b) Follow-up on the implementation of the EU priorities in combatting serious and organised international crime

<u>The Committee</u> was informed about the Presidency's intentions to inform the Council on the results of the large scale law enforcement operation (Operation Archimedes) which took place between the 15 and 23 September 2014 and to organise a policy debate on the Member States' role and input in the EU's fight against serious and organised crime, and in particular the setting of crime priorities and possibilities to effectively bring together resources at EU level.

c) Foreign fighters: follow-up on the conclusions of the European Council of 30 August 2014

<u>The Committee</u> welcomed the initiative of the Presidency to discuss the issue of foreign fighters at the Council and considered that the topics suggested for discussion were very relevant under the current circumstances. There was broad support for the need to revive the discussion on the PNR with the EP with a view to making substantial progress on the file. It was suggested to also examine the exchange of Advance Passenger Information.

On the issue of checks at external borders, delegations agreed that efforts leading to better use of existing instruments are needed. Some were of the view that experts should first examine what can be done under the existing legislation, before making any requests to the Commission to make formal proposals.

<u>The Chair</u> briefly presented the document and the question to be submitted to ministers. Some delegations questioned the timeliness of the question, and others suggested a slight reformulation of it. Most delegations supported the general thrust of the question. <u>The Chair</u> took note of the discussions and stated that the document would be modified slightly in line with comments received.

f) Proposal for a Directive of the European Parliament and of the Council on the strengthening of certain aspects of the presumption of innocence and of the right to be present at trial in criminal proceedings (First reading)

<u>The Chair</u> briefly presented the Presidency note to the Council regarding 'the right to be forgotten'.

<u>The Committee</u> discussed extensively the revised Presidency note on Chapter IV, which was widely welcomed. <u>Some delegations</u> nevertheless referred to a few outstanding issues.

Following this discussion, the Chair indicated that the only issue on which further discussions would be held prior to the Council was the scope of the obligation for non-EU controllers to appoint representatives (Article 25).

Germany made the below statement:

"Statement by Germany on Chapter IV of the proposal for a General Data Protection Regulation as set out in Council document 12312/4/14 REV 4:

Germany supports the partial general approach under the conditions listed in paragraph 8(i) to (iii) of the document. Germany reserves the right to return to the requirement for the mandatory appointment of a data protection officer for specific processing situations, due to its central importance in concluding discussions on the text."

#### i) Other items in connection with the Council meeting

The Presidency added one AOB item to the Council agenda:

"Outcome of the High Level Conference on a Renewed EU Internal Security Strategy".

<u>The UK</u> requested that the "Application of Article 10 of Protocol 36 to the Treaties" be also included on AOB.

When adopting a General approach after the European Parliament has adopted its position at first reading, the Council is not acting within the meaning of Article 294(4) and (5) TFEU.
