3. **Commission Delegated Regulation (EU) No 992/2014 of 22.9.2014 repealing Delegated Regulation (EU) No 950/2014**

- Outcome of the written consultation

The SCA confirmed that it had no intention to object to the delegated act and it assumed that the Council does not intend to object to it.

The SCA took note of the position of the Danish delegation and noted the absence of a qualified majority in the Committee to object to the Commission delegated Regulation (EU) No 1031/2014 of 29 September 2014 laying down further temporary exceptional support measures for producers of certain fruit and vegetables.

The Cyprus delegation, while approving the Commission delegated Regulation, requested its extension for an additional two months period.

5. **Russian import ban on EU agricultural products**

- Information from the Commission regarding possible additional measures for the milk market

The SCA took note of the information provided by the Commission representative on possible additional measures to counter the effects of the Russian import ban in the dairy sector, as well as of the views expressed by delegations.

The SCA took note of the report on the outcome of the examination of the draft resolutions and of the Commission proposal by the Working Party on Wines and Alcohol (OIV) on 19 September 2014 (doc 13744/14).

The SCA also took note of the Commission's intention to revisit the relevant infringement procedures against 21 M.S. against the background of the preparations for the General Assembly meeting in Mendoza and the adoption of the draft Council Decision.

The SCA considered the draft Council Decision on the basis of the Presidency suggested amendments to the Commission proposal (doc 13190/14) and noted that no delegation opposed. Therefore it confirmed its intention to invite the Council to adopt the Council Decision at its meeting on 28 October 2014 as an "A" item.

The SCA approved the draft letter to the Commission as amended in the meeting, with a view to forwarding it to the Council for adoption.

The SCA took also note of some delegations' comments as well as of the statement made by the Czech delegation, supported by the Hungarian and Slovak delegations, that it would be preferable to keep the two schemes separate. The Czech delegation also stated that if the schemes had to be merged, this should not be done before 2020.
