The balance of commitment and payment appropriations currently available on the reserve line is sufficient to cover the increase on the operational line.

The amounts not used up to year-end mentioned above also include EUR 71 million in commitment appropriations and EUR 69.6 million in payment appropriations that the Commission has proposed to reduce in draft amending budgets 3 and 4/2014.

d) Detailed grounds for the transfer

For almost all Sustainable Fisheries Partnership Agreements reference levels of tonnage are used to calculate the initial amount due from the European Union for vessel access in waters under the jurisdiction of third countries. This baseline may not be considered a catch limit associated with a specific conservation goal or management. The Protocol attached to the Agreement signed on 09/10/2012 between the European Union and the Republic of Kiribati also provides the possibility of exceeding the reference level (set at 15 000 tonnes), with an additional fee of EUR 250/tonne for the first 2 500 tonnes and EUR 300/tonne for each additional tonne, with a maximum of EUR 65/tonne to be paid from the budget of the European Union and the rest being paid by the ship owners. According to the information submitted by the Republic of Kiribati on additional catches for 2013, there is an excess compared to the reference tonnage, which results in a EUR 396 305 additional payment from the EU budget, which needs to be mobilised in commitment and payment appropriations to respect the legal obligations.
