### Item 4 on the agenda

Financial rules applicable to the general budget of the Union

• Exchange of views

The rapporteur presented the main elements of Commission's proposal to amend the Financial Regulation, including the carry-over rules for the Emergency Aid Reserve, projects under the Connecting Europe Facility and for unused appropriations.

In addition, Ms GRÄSSLE pointed out that she could not accept the discharge procedure for public-private partnerships (PPP) as proposed by the Commission in its draft delegated act. She proposed to open the discussions on Article 209 of the Financial Regulation.

The Commission representative (Director-General Mr JOUANJEAN) reminded the Committee that the current wording of the Financial Regulation was already accepted by both Parliament and Council. He indicated that the proposed discharge procedure for PPPs addresses the needs of simplification and increased efficiency and suggested having a mid-term review of PPPs' discharge procedure.

Mr KALFIN (S&D, BG) indicated that further changes are needed in the Financial Regulation following the Common Provision Regulation (CPR) agreement in the field of Cohesion.

Moreover, Ms GRÄSSLE stated that the Financial Regulation should also be updated in order to address the treatment of funds resulting from the agreements on the fight against the illegal traffic in tobacco products.

Following the questions raised by Mr GEIER (S&D, DE) and Mr MULDER (ALDE, NL) on the timetable for adoption of the amended Financial Regulation, the rapporteur indicated that she targeted the Plenary session in January 2014.

The rapporteur, supported by Mr FERNANDES (EPP, PT), welcomed the Commission's proposal on the new European Union Solidarity Fund (EUSF). He presented his draft opinion, which included amendments aimed at speeding up the assessment process, lowering the threshold for what constitutes a 'regional natural disaster' to 1% of the region's gross domestic product (GDP) and fixing the amount of the advance payment at 15% of the amount of the contribution anticipated.

The Commission representative recalled that the EUSF does not replace national instruments. He indicated that should the regional threshold be lowered, the number of eligible cases would automatically increase, imposing more pressure on payments during the next multiannual financial framework.

The rapporteur presented her draft opinion on EBA's short-term office accommodation contracts. She noted that the Agency had failed to notify the Budgetary authority prior to the signing of rent contracts with significant financial implications. She invited both Parliament's Committee on Budgetary Control (CONT) and Court of Auditors to scrutinise the contracts

signed in the framework of their annual discharge and audit procedures.

Mr LYON (ALDE, UK), supported by Mr ASHWORTH (ECRF, UK), backed the rapporteur's

opinion whereas Mr GEIER (S&D, DE) recalled that it was a political decision to locate the

three European Supervisory Authorities in some of the most expensive locations in Europe.

Mr RIQUET (EPP, FR), Mr MULDER (ALDE, NL) and Ms WERTHMANN (ALDE, AT)

wondered whether it would be possible to hold accountable the person responsible at EBA.
